## Executive Board Meeting Minutes from June 16, 2023

**EcoHarvester Operations**: Kim Phelps shared the schedule for Teal & Lost Land Lakes for running the harvester. Carolyn will create a message to members that will be emailed as a dedicated email requesting volunteers after approving volunteer request information with Gary Keil, Michelle Keil & Kim Phelps. Regarding the insurance claim on the harvester, we had 118 man hours for repairs & paid the deductible (\$1,423.00) for claim from damage on harvester during winter storage months. The insurance claim will cover labor, gathering wheel, chain drive motor + misc. parts.

**Treasurer's Report**: Perry Cowan reviewed budget with the board and created updated budget figures. Membership dues are ahead of last year for the first 6 months. We are \$26K ahead of projection for the first 6 months of the year.

**Consultant Update**: The board officially signed the consulting agreement with the NWRPC & consultant with NWRPC, Megan Mader. Megan will continue our grant writing & submittals for our Large Scale Population Grant & grants related to our APM. We will have simultaneous consultants during the transition from LEAPS LLC (David Blumer) to NWRPC (Megan Mader with the Northwest Regional Planning Commission). We will define QLIA's individual roles for action plans after we have the APM & LSPG completed.
