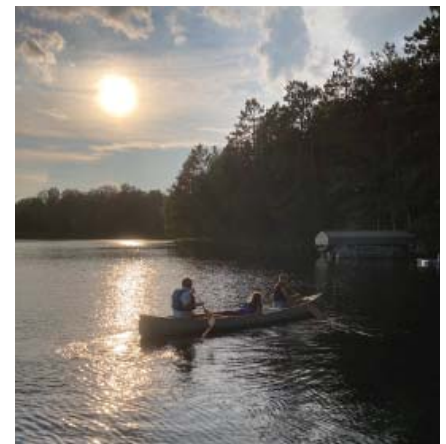

QLIA Lake Projects - Lake EWM Treatment Update

Eurasian Water Milfoil (EWM) What is it?

Eurasian water milfoil (*Myriophyllum spicatum*) is a submerged, rooted aquatic plant that is native to Europe, Asia, and northern Africa. It has feather-like green leaves that grow in whorls of four or five around the stem, with each leaf having 12 or more thread-like segments. The stems are usually light brown or pink, but can also be whitish-pink or reddish-brown. The tips of the plant can sometimes be red or pink, but color alone shouldn't be used for identification because it can vary.

In late July and early August EWM produces tiny pink flowers on reddish spikes that rise several inches above the water. This invasive species reproduces through fragmentation, meaning that a single stem fragment can take root and establish a new population in a water body. Boat traffic is responsible for the majority of introductions into new water bodies, as the plant can become entangled in boat propellers, keels, rudders, and trailers. The stems that get lodged in these watercraft and trailers are then transported to other water bodies, where they can colonize new areas.

EWM In Our Lakes

In 2022, the Quiet lake Improvement Association (QLIA) obtained a State Surface Water Grant to assess the status of Teal and Lost Land Lakes. This survey indicated there are 21 Eurasian Water Milfoil beds covering 263 acres in Lost and Teal Lake has 35 Eurasian Water Milfoil beds covering 44 acres. If left uncontrolled, EWM can significantly harm the lakes' overall viability and short and long-term health. This aquatic invasive plant obstructs boating and fishing, disrupts the ecosystem and biodiversity of our lakes, and reduces our property values.

2024 Treatment Plan Overview

In early June 2024, in collaboration with DNR scientists and our lake consultants, our initial chemical treatment included a targeted ProcellaCOR treatments on targeted areas in both lakes:

***Lost Lake Lake - Treatment of 30 acres
Teal Lake - Treatment of 6 acres***

The ProcellaCOR herbicide was applied at carefully calculated concentrations to maximize effectiveness while minimizing environmental impact.

Our certified ProcellaCOR applicator, with nearly 40 years of experience, oversaw the treatments. The plan also includes mapping surveys to document the current EWM beds in each lake before and after treatments to monitor effectiveness and to measure how the herbicide spreads throughout the lakes after treatment occurs.

QLIA Lake Projects - Future Funding Needs

QLIA Fundraising Update

We have set a goal of \$100,000.00 in order to meet our expected annual costs for EWM chemical treatments for our quiet lakes.

Costs for EWM in 2024 were \$81,000.00. The cost for treatments are expected to remain the same or increase in 2025, meaning that we would have a shortfall right now of \$79,850.00.

QLIA total donations through August 5, 2024 were \$20,150.00. This leaves us a total deficit of \$79,850.00 for EWM treatments in 2025.

If we built up a budget surplus that could be carried forwarded each year, this would ease the burden on our fundraising efforts that are necessary to help with the EWM in our lakes. This is where we need everyone's help!

Fundraising Plans

Summerfest was a great success raising over \$12,000. However, part of the goal was to grow the participation and membership, unfortunately this is where we fell short of that goal. Membership only grew by ???

Our Future Needs

It's crucial to recognize that managing Eurasian Water Milfoil (EWM) will be an ongoing process requiring sustained funding immediately and for many years to come to effectively control its growth and spread in Lost Land and Teal Lakes. The estimated costs of treating EWM ranges from \$400,000 to \$600,000 over multiple years.

State grants may cover up to 75% of the costs, but the QLIA will need to raise significant funds each year to fight EWM in our lakes.

Annual dues alone are insufficient to support these initiatives as they are capped at \$50 per individual by State Law.

We are asking for annual contributions to our Tier Program to **Preserve and Protect** our lakes. The funds will be used to control and manage the EWM population, ensuring the long term preservation and enjoyment of the lakes for generations to come.



Permits and Weed Control

Department of Natural Resources Post-Treatment plant survey evaluation of the June 7th ProcellaCor treatments will be available this fall. We are working with the Wisconsin Department of Natural Resources to obtain this survey information as soon as it's possible so we can get this information out to our members.

Chemical permits for 2025 treatments will be applied for as soon as possible after the evaluation is completed. Permits for 2025 cannot be applied for until the results of the 2024 treatments have been evaluated. Timing is critical and we are on top of it.

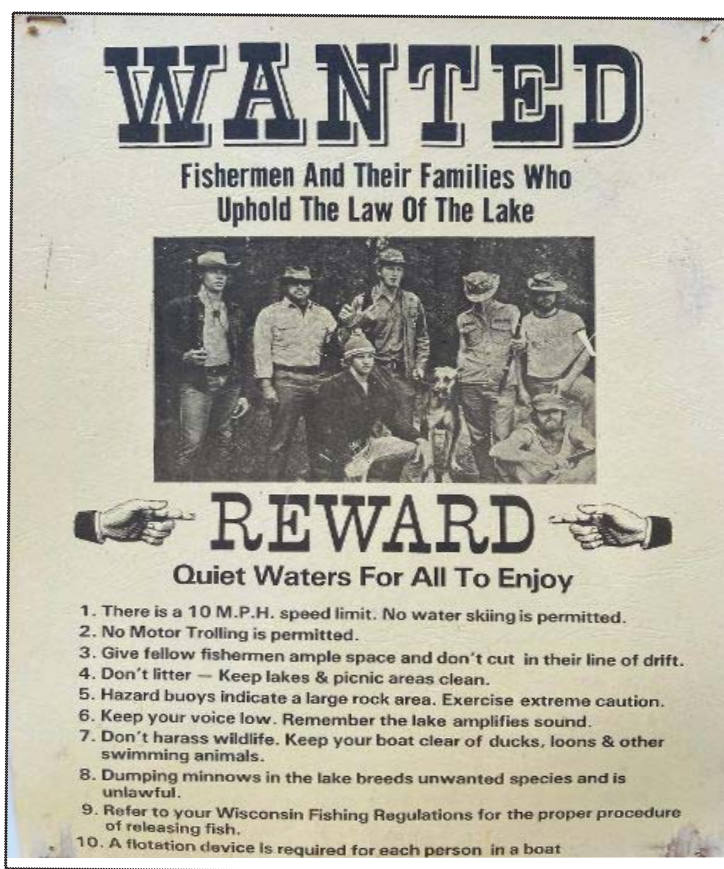
